Parade Guidelines & Information

PLEASE read to all members of your parade entry.

1. To facilitate the flow of traffic, all parade entrants **must** enter San Jacinto Street from Highway 20 West (State Park Road).
2. Parade entrants should line up on San Jacinto Street and be in position **no later than 9:00 a.m.** prepared to start moving along the Parade Route at 9:30 a.m. (In place by 8:30 a.m. for Judging).
3. **To prevent injury to Parade spectators no flowers, samples, candy, or anything what so ever may be thrown from any Parade entry.**
4. Please maintain a safe distance from the entry in front of you (2 - 3 car lengths).
5. Parade winners will be presented their award(s) before the parade begins.
6. The announcer's script will be written and typed prior to the parade. If you have any information you did not include on your entry application, please contact the Chairperson listed below. Please be **CONCISE** in your description.
7. The Parade begins promptly at **10:00 a.m.**

PUBLIC CONSUMPTION OF ALCOHOLIC BEVERAGES BY PARADE PARTICIPANTS IS STRICTLY PROHIBITED.

JUDGING WILL BEGIN PROMPTLY AT 8:30 A.M.
To be eligible for judging all entries must be in place with participants in position at 8:30 a.m.

Parking for horse trailers is available on Center Street in the parking lot of Navarro Elementary School.
